

At Remypatra Hair Industries, one of our main priorities is the privacy of our visitors.

This Privacy Policy document contains types of information that is collected and recorded by Remypatra Hair (“**Remy**”, “**We/we**” or “**Us/us**”) and how We use it with regard to User’s (“**You/you**” “**User/s**” or “**Your/your**”) use of the online platform [www.remypatrahair.com/](http://www.remypatrahair.com/) (“**Website/Web Application**”).

Please read this privacy policy (“**Policy**”) carefully before using the Website and its services. Your use of the Website or registrations with us through any mode or use of any products including that of any storage/transmitting device shall signify your acceptance of this Policy and your consent to be legally bound by the same. If You don’t agree with this Privacy Policy, then You are advised not to use/access this Website.

We regularly review this Policy to make sure it is up-to-date. If you are a visitor, please note this Policy is subject to change at any time without any prior notice. To make sure you are aware of any changes, please review this Policy periodically. If you have additional questions or require more information about our Privacy Policy, do not hesitate to Contact Us.

This Privacy Policy applies to our online services and is valid for visitors on our Website with regards to the information that they shared and/or collect. As a visitor, one can browse Website to find out more about it. Visitors are not required to provide with any Personal Data. This policy is not applicable to any information collected offline or via channels other than this website and the Policy is published in compliance of the (Indian) Information Technology Act, 2000 and the rules, regulations, guidelines and clarifications framed thereunder, including the (Indian) Information Technology (Reasonable Security Practices and Procedures and Sensitive Personal Data or Information) Rules, 2011.

## **INFORMATION WE COLLECT**

(c) information provided by user for help and technical assistance; (d) information entered into device when using the Web Application.

The above information collected from the Users could be categorized as “Personal Information”, “Sensitive Personal Information” and “Associated Information”. If User contact us directly, we may receive additional information about him/her such as name, email, address, phone number, the

contents of the message and/or attachments you may send us, and any other information you may choose to provide.

### **General Data Protection Regulation (GDPR)**

We are a Data Controller of your information.

Remypatra Hair Industries legal basis for collecting and using the personal information described in this Privacy Policy depends on the Personal Information we collect and the specific context in which we collect the information:

- Remypatra Hair Industries needs to perform a contract with you;
- You have given Remypatra Hair Industries permission to do so;
- Processing your personal information is in Remypatra Hair Industries legitimate interests;
- Remypatra Hair Industries needs to comply with the law  
Remypatra Hair Industries will retain your personal information only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use your information to the extent necessary to comply with our legal obligations, resolve disputes, and enforce our policies.  
If you are a resident of the European Economic Area (EEA), you have certain data protection rights. If you wish to be informed what Personal Information, we hold about you and if you want it to be removed from our systems, please contact us.  
In certain circumstances, you have the following data protection rights:

- The right to access, update or to delete the information we have on you;
- The right of rectification;

## **HOW WE USE YOUR INFORMATION**

We use

the collected information in various ways, including: -

1. Providing, operating, and maintaining our Web Application;
2. Improve, remove glitches/bugs, personalize, and expand our Web Application;
3. Understand and analyse how users use our Web Application;
4. Develop new products, services, features, and functionality for our users;
5. Communicate with user, either directly or through our affiliates, including customer service, to provide you with updates and other information relating to the Web Application, and for marketing and promotional purposes;

6. Send you emails;
7. Find and prevent fraud;
8. Statistical Analysis.

[Remypatra Hair Industries](#) follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this as a part of hosting services' analytics. The information collected by log files include internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp and exit pages. These are not linked to any information that is personally identifiable. The purpose of the information is for analysing trends, administering the site, tracking users' movement on the website, and gathering demographic information.

## **WITH WHOM WE SHARE YOUR INFORMATION**

We share information as discussed below, but we won't sell it to other third parties. We share your personal data with your consent or to complete any transaction or provide any product you have requested or authorised. We also share data with Web Application-controlled affiliates and subsidiaries; with vendors working on our behalf; when required by law or to respond to legal process; to protect our customers; to protect lives; to maintain the security of our products; and to protect the rights and property of Web Application and its customers.

*Affiliates and Third Parties working for and with Web Application.*

Affiliates such as user support provider, our payment processors, email processors and the accountant. The use of the Affiliates and third-party software links on this Web Application is done at your own discretion and risk and with agreement that you will be solely responsible for any damage to your computer system or loss of data that results from such activities. You are solely responsible for adequate protection and backup of the data and equipment used in connection with any of the software linked to this website, and we will not be liable for any damages that you may suffer connection with such software and we shall not be liable for their misconduct regarding your information.

*Law & Order and the Public Interest.*

We may disclose your information to third parties if we determine that such disclosure is reasonably necessary to: (a) comply with any applicable law, regulation, legal process, or appropriate government request; (b) prevent fraud or abuse of Web Application or our users; (c) protect Web Application's rights, property, safety, or interest; or (d) perform a task carried out in the public interest.

#### *Business Partners.*

We collaborate with advertising partners, marketing and communication agencies. We do this for (interest based) advertising, branding and reaching out to you.

#### *Integrated services.*

If you decide to integrate our Services with another service (your social media account) we will connect that service with ours. In order to provide such service, we will need to share some of your personal information with that service. The terms and privacy & cookie statement of these third parties applies, at least for their part of the connection.

We will retain, access, transfer, disclose, and preserve personal data, including your content (files in folders), when we have a good faith belief that doing so is necessary to do any of the following:

- Comply with applicable law or respond to valid legal process, including from law enforcement or other government agencies.
    - Protect our customers, for example, to prevent spam or attempts to defraud users of our products, or to help prevent the loss of life or serious injury of anyone.
    - Operate and maintain the security of our products, including to prevent or stop an attack on our computer systems or networks.
    - Protect the rights or property of Web Application, including enforcing the terms governing the use of the services—however, if we receive information indicating that someone is using our services to traffic in stolen intellectual or physical property of Web Application, the Admin of Web Application will inspect a customer's private content and if needed we may refer the matter to law enforcement too.
- Stewardship of your data is critical to us and a responsibility that we embrace. We believe that your data should receive the same legal

### **COOKIES AND WEB BEACONS**
